ANNUAL MEETING

JANUARY 19,2025

Father Joe gave opening prayer.

10:25 - Meeting convened and polls opened for balloting

Allen Wolf explained voting procedure.

No nominations from floor

Polls close in one hour- 11:25

Susan Allen was appointed clerk of the annual meeting

Jeannie LaMere volunteered to be vestry clerk for 2025.

Sue Purdy welcomed and introduced new members Ken and Carol Souser.

Allen Wolf moved to accept 2024 annual meeting minutes; Leslie Harper seconded. Motion approved.

2024 Financial report by Tina Santy

\$16K more in surplus than was budgeted. Excess will roll over to FUNDS, and use will be determined by vestry. 2025 budget has a deficit of \$28K, mostly due to loss of Head Start lease.

About \$200k in reserve- some money is restricted; some is not.

Unified fund account has \$175K, Money market at Seneca Federal is \$199,500. CD is \$35K.

This year Capital improvement funds paid for blacktopping parking lot and repairing roof, and new church sign.

2025 budget was approved by vestry in December 2024.

2022 and 2023 audits are complete and submitted to the diocese.

The 2024 audit will be done professionally, as required, during the 2025 calendar year. (This is budgeted over 3 years.) Snow plow contract is paid in lump sum, so that it is cheaper. More student parking could be rented since no one is using the church during school hours to help with revenue.

Discussion on liability in parking lot, as well as sledding on the hill. Barb Reeves will check with Cathy Hobart and report back. Vestry will discuss snow fence installation.

Brad Pettit was remembered for his service and contribution to the church.

Barb Reeves addressed church members, thanking them for their contributions, and encouraged everyone to donate flowers, come to events, and host hospitality hours.

Allen W. Reinforced communication with the office. All announcements, flower orders, events need to be sent to the office and Allen will send information to the appropriate person or group.

New keys have been made and assigned. All key holders must attend 'Safe Church' training in person or online. Since florist will not receive a key, Barb will work with them on delivery protocol.

Allen suggested that the Memorials Ministry be resurrected, and initiate a Visions committee to work on how to reuse space and reconfigure existing rooms. Recent donations of \$10K and \$2K will allow the church to repair necessary areas. We need to clean out and brighten up spaces. Meetings of present ministries need to occur so that past and present members of these committees can compile information that they have.

Nancy Fredette mentioned needing more people to serve as counters. Most committees could use more involvement.

Father Joe's commented that hope, energy, and interest are thriving in our church with optimism for the future. We are looking for potential groups to lease our space and will reach out to local religious groups who are leasing other spaces. Ideas can be brought to vestry members or the monthly meeting.

Barb moved to close the polls and Diane Coe seconded. Motion approved. Tom LaMere moved to accept the slate of nominations for vestry. Carla Wiemers seconded. Motion approved.

Barb Reeves thanked outgoing vestry members, Sue Purdy and Pam Griffo. She then welcomed Stacey Wolf, Tina Santy, and Nancy Fredette as new members of vestry.

Stuart Allen moved to adjourn at 11:35; Allen Wolf Seconded.
